Child Abuse and Neglect:
Henrico CASA is the only court advocacy program for abused and neglected children in Henrico County and this service is offered at no charge to the children or their families. CASA volunteers commit to working with children for the entire duration of their court case with the goal of securing safe, stable placements, and the prevention of further abuse or neglect.

Specific achievements include: 329 children were assigned an advocate in the fiscal year; celebrated 28 years of advocacy to Henrico County's children; and served 3,750 child victims since 1994.

Volunteers: CASA volunteers advocate for children from birth to eighteen. Without an advocate, hundreds of abused and neglected children would not have a strong voice in their corner. CASA volunteers complete 40 hours of in-person training and once assigned a case, conduct an independent evaluation of each child's circumstances, focusing on the safety and well-being of the child.

Specific achievements include: 119 active volunteers with an average length of service of 4 years; 95% of children had the same dedicated and consistent advocate throughout the entirety of their case; volunteers dedicated 10,452 hours and made 23,993 contacts with family members and case professionals; value of \$321,890 if volunteers were

Reporting:
The final work product of each volunteer advocate's efforts is a detailed report to the Court, complete with a case history, documented factual findings, and recommendations for placement and family stabilization services.

Specific highlights include: 119 volunteers attended 400 hearings and submitted 377 reports; 99% of children were placed in safe, stable, home environmentse at the close of their case, 97% of the recommendations considered by the juvenile court judges were accepted and made part of a court order.
