In accepting a two-year appointment, an individual agrees to fulfill the requirements and meet the responsibilities associated with Board membership.

Attendance at Meetings

Attending and participating in all scheduled Board meetings is very important to work strategically on behalf of **CASA**'s mission, goals, and objectives. Meetings are generally held bi-monthly, but may be scheduled as needed, throughout the fiscal year (July 1 to June 30). If any member misses two or more regularly scheduled meetings in a program year, the Board may, in its sole discretion, remove the member and declare the seat vacant.

Supporting **CASA**

As a Board Member, you are an important spokesperson and supporter for our mission! You may be asked to attend events and/or represent **CASA** at community events and fundraising activities. This could include talking with prospective donors or volunteers or introducing staff to important business acquaintances or community members. Members are expected to support **CASA** with an annual gift at a level meaningful to your household, and by requesting corporate matching gifts or Board-directed grants (where applicable).
