CASA Story

As we embark on a new fiscal year, it is important to reflect on the previous year and a reminder of what our organization does daily. When CASA receives grants for corporations or foundations, we are often asked to report back on our results. Here is a recent answer to a question on a grant report to Altria that outlines our accomplishments. Let this serve as a reminder of the needs of the children we serve, the work of our advocates, and the impact of funding we receive!

With relentless dedication, Henrico CASA ensures that the child welfare system remains determinedly focused on the safety and permanency of each child, leaving no room for any child to be lost within the protective confines of the system. Henrico CASA's mission is an unwavering commitment that shapes our daily efforts. CASA volunteers have evolved into a vital cornerstone of the child welfare initiative, working in tandem with attorneys, social workers, and service professionals to elicit vital information about a child's health, developmental milestones, and educational requirements.

Child abuse and neglect, as we have come to know, recognizes no boundaries. Regardless of income level or demographic, these harrowing experiences permeate all corners of society. Henrico CASA stands as a steadfast guardian for all children, irrespective of their circumstances, who have endured the cruel touch of abuse or neglect. These children, united by their heart-wrenching pasts, embark on a tumultuous journey through the intricate labyrinths of child welfare and juvenile court systems. Their challenges in health, education, and personal development stand unparalleled, yet their struggles are met with the unwavering support of a CASA volunteer. Our work remains crucial, as children under the care of a CASA advocate have a voice in court proceedings, gain improved access to essential services, and encounter fewer disruptions in placements and schooling.

Central to our vision, the grant generously bestowed by Altria's Give Together program fortified Henrico CASA's ability to recruit, screen, and train volunteer advocates, thus amplifying our agency's commitment to serve *every* abused and neglected child referred to our agency. CASA volunteers engage with all family members and case professionals, fostering collaborative relationships with social workers, attorneys, and counselors. They stand as steadfast companions, consistently visiting the child and meticulously evaluating health, mental well-being, and academic records. At critical hearings, the profound impact of a CASA volunteer's involvement resonates as they present judges with meticulously detailed reports containing historical context, factual findings, and insightful recommendations – all instrumental in guiding the court's decisions about each child's future.

In the previous fiscal year, our program embraced 27 new volunteer advocates across four rigorous training sessions. Demonstrating unwavering dedication, our volunteers admirably served every single one of the 359 children referred to our agency (a 10% increase from last year), collectively contributing more than 10,400 hours of invaluable service. Impressively, they engaged in over 22,000 interactions with children, family members, and case professionals and submitted more than 350 detailed reports, encompassing comprehensive insights into the children's lives and families. A staggering 97% of the advocates' recommendations were assimilated into court orders, attesting to the profound impact of their involvement. The ongoing success of our recruitment endeavors is also evident, with our upcoming training session scheduled for this fall (September – October 2023) already at full capacity.

A testament to the steadfast commitment of our advocates, 97% of children were accompanied by the same advocate throughout their journey, nurturing stability and trust. Perhaps most importantly, 99% of children found themselves in secure and stable homes by the time their cases were concluded. Our advocates' profound influence ensures that each child's best interests are fervently safeguarded, resulting in an uplifting conclusion to each chapter of their stories.

The impact of Altria's grant radiates through every facet of our CASA program. The increased capacity to recruit volunteers means that more children have found a steadfast ally in their corner – an advocate who listens to their stories, stands by them through court proceedings, and tirelessly works to help identify safe environments and helpful resources. This grant's support for screening and training has elevated the quality of our advocates, equipping them with the tools and knowledge needed to navigate complex situations with empathy and expertise.

In a larger context, the resilience of the nonprofit sector hinges on both sustainable programs and steadfast funding. Henrico CASA has recognized the importance of fostering collaborative partnerships within our local community, nurturing alliances that bolster our ability to serve vulnerable children. A poignant example of this collaboration is our partnership with Altria, an embodiment of shared purpose. Since 2005, Altria Give Together has consistently championed Henrico CASA, symbolizing the belief that the prevention of child abuse and neglect holds the key to forging a wholesome future for our community.

The impact of Altria's Give Together grant not only reverberates through the data but resonates profoundly in the lives of children who are finding their voices, advocates who are beacons of hope, and families who are embracing healing and transformation. Together, with Altria's support, Henrico CASA is illuminating a path toward brighter futures, one child at a time.

Governance Committee (GC) Notes July and August 2023 Meetings

The GC has reengaged with Katherine Whitney of Warren Whitney for consultation and guidance as we move forward with progressive member and advisor recruitment and succession management.

The GC has concluded that continuing to manage Board terms, prospective members will be brought on as advisors and if elected by the current Board, will be seated and begin their term of service in alignment with the fiscal year.

In August, two additional advisors were approved by the GC for the Board to vote on as advisors (Nick Cooper and Berkeley Edmunds). They will begin as advisors immediately.

We continue to evaluate candidates based on where the matrix shows skill gaps in order to ensure a well-balanced Board. The Board will receive a form to fill out and return so the skill matrix can be updated. Once updated, the completed matrix will be sent out to all members so they can see where we have identified gaps and the recruitment efforts should be focused.

The GC encourages and expects current Board members to be proactive in seeking out quality candidates to join the Board identify potential donors. Potential Board member/advisor information should be sent to the GC for evaluation and discussion. For *donors* that a member is not comfortable soliciting themselves, their contact information and a brief background shall be sent to the Development Committee so they can assign a member to engage with them.

Bio for Berkeley Edmunds

Berkeley was born and raised in Richmond, Va. He graduated from St. Christopher's School in 1991 and Hampden-Sydney College in 1995. He started his career as an Institutional Equity Sales Trader for Wheat First Butcher Singer here in Richmond where he met his soon-to-be wife Cheney on the trading floor. Through multiple mergers, he eventually moved to Baltimore with First Union, which became Wachovia, and finally Wells Fargo.

Berkeley married Cheney in 2002 and they settled in Annapolis. Going on the boat, picking crabs, and attending as many live music shows as possible in the DC / Baltimore is where you would find them. When they decided to start a family, they didn't look back. They welcomed boys Berkeley, Jr. in 2006, Bower in 2007, and daughter, Serpell, in 2008. Having 3 kids under the age of 2.5 years was quite the story line.

Wells Fargo eventually shut the Baltimore office down in 2013 and they moved back to Richmond. Berkeley purchased his childhood home from his parents as they were moving to Westminster-Canterbury. While Berkeley was looking for a job in finance in Richmond, he ended up taking a job again as a Sale Trader with Stifel Nicolas in Baltimore. After two years of commuting, he took a job back in Richmond with BB&T Capital Markets in 2015. However, BB&T shut down their equity group a year later, and Berkeley decided to look for something outside of finance. When Covid kicked in, he pivoted and entered house flipping. He also volunteers his time with St. Stephen's Episcopal Church HANDS Ministry (Hammer And Nails in Devoted Service). Cheney has been the Editor and Owner of the The Scout Guide Richmond for almost ten years. The Scout Guide is a franchise headquartered in Charlottesville with locations in over 80 cities that produce a yearly publication promoting local businesses.

Bio for Nick Cooper

Nick is the Managing Principal and Design Director for Hanbury Architects' Richmond office who leads the design of projects and the pursuit of new work across the entire Mid-Atlantic Region. His almost 20-year career has focused on Mixed Use, Commercial, Multifamily, Adaptive Re-use, Healthcare and Civic projects emphasizing a cross-sector influence where he believes the most innovative solutions emerge.

Nick is known for his award-winning design around the world but is most proud of his community-based work through thought leadership and service to Richmond's Storefront for Community Design, and previously as the Director of Citizen HKS, the firms' public interest design and community engagement studio.

Richmond's Style Weekly honored Nick with a 40 under 40 Award in 2018 for excelling professionally and serving as an example of innovation, leadership, and service to the community. [He is just one of two architects to be awarded the honor since Style launched the program more than 35 years ago.] Nick is most passionate about mentoring and empowering the next generation of critical thinkers at Hanbury and throughout Richmond as he serves as the 2021 Chair for AIA Virginia's ELA program and has transformed AIA Richmond's YAF Committee the last three years.

Nick is a graduate of Virginia Tech and a long time Richmond resident. He is married with 2 kids. Nick is very familiar with CASA's mission – on a personal note, he was raised by his grandmother and he and his family used to participate in the CASA Superhero Run for years.

Fund Development (FD) Committee June, July, and August Meetings

On the heels of Home for Good[®] (HFG) 2023, the CASA FD Team spent the majority of the summer months (June 2nd, June 20th, July 24th, and August 11th) focused primarily on our Key Partners for HFG 2024, but also on a "Thank You" party for HFG sponsors to take place this fall 2023.

- HFG "Thank You" Party Thought this event would be a good way to bring past sponsors back to thank them for their support, remind them of the CASA mission, and let this event serve as a get to know CASA for future prospective partners. Date to be announced but looking like October 2023.
- Over the summer, the fundraising efforts were focused on identifying Key Sponsor (\$10,000+)
 prospects for HFG. Long-term goal is to identify a local company that will serve as our title
 sponsor. During these meetings, discussions were had to identify the types of companies that
 would make good fits for CASA, some review of what CASA can offer a title sponsor and organize
 our prospects in a priority fashion.
 - Ideal Prospect A company that has some form of home or individual well-being built into their own company mission with a community focus on helping children. While this is broad, it serves to help eliminate several companies that would likely not be a fit.
 - What CASA Offers Sponsors we have to be aware that sponsors make decisions based on their community missions, but also on what will benefit their business. Still working on this analysis.
 - Prospect Ranking spent a lot of time discussing individual company prospects and the value of the relationship. This exercise helped us rank prospects in an appropriate manner to focus and to keep us accountable.

- Currently the FD Team is working on the Key Prospects in order to get HFG 2024 on their radar as they begin to make budgetary decision for 2024, specifically with any charitable donation dollars. Next FD meeting in mid-October 2023 will focus on a follow up on Key Prospects.
- Cabell Foundation: Rutherfoord will report out on Director's Grant to the benefit of Henrico CASA two important observations to share!

Finance Committee Notes August 2023 Meeting

- 1. Update from Alpha Omega (AO)
 - AO reviewed their compliance with the Henrico CASA investment policy. All is in compliance except the proportion of fixed income investments is slightly higher.
 - AO presented their outlook for stock market. They are perhaps less optimistic than other investment firms that the stock market will appreciate, hence our investment portfolio currently leans heavily toward fixed income investments and cash.
- 2. Revisions to the Investment Policy
 - AO had shared suggested changes to our Investment Policy with us last fall. After initial discussions, Rutherfoord and Mary Jo worked to harmonize comments from the committee with the AO draft.
 - In early 2023, the Finance Committee met again to consider a harmonized draft. The final unresolved issue was the level of desired granularity in describing the investment classes and their definitions. A decision was deferred until the Home for Good[®] campaign was over.
 - The Committee revisited this issue along with input from Clay and Everett. The Committee decided to retain the categories, minima, maxima, and targeted levels in our current policy, with the only change being to combine the fixed income and cash categories, adjusting the maximum, minimum and target levels accordingly.
 - The Committee is ready to ask the full Board to consider its new draft at the October 2023 Board meeting.
- 3. Level of cash reserves
 - Our auditor, Sharon Hart, CPA, suggested last year that we might want to revisit our current policy of having at least 75% of our annual operating budget kept in liquid assets. Jeannine revisited this with her this year.
 - In light of our current stable financial situation with stable sources of income, Sharon suggested that we need not keep such a high percentage of the budget in cash-equivalent assets.
 - Additionally, we are earning higher returns in the AO investment account than we are in the checking or reserve accounts, so we are losing out on higher asset returns by holding excess liquidity.
 - After robust discussion, the committee decided that it would change the 75% rule to 50%.

- 4. Frequency of movement of excess cash to investment accounts and approval thereof
 - The Committee discussed how often to move excess cash to the AO investment account, which has happened annually in the past few years. This year the result was that AO received a large influx of money to invest at a time when it is cautious about the stock market.
 - After discussing annual, semi-annual, and quarterly movements, the committee decided that proposals to move money into the investment accounts would be considered by the Finance Committee at any time that the Executive Director and the Treasurer recommend.
- 5. Final FY 2022-23 financial statements were reviewed.
 - No questions were raised.

Visitation Center (Ad Hoc Commitee) August 2023 Meeting

The Committee has identified that the next steps for the Visitation Center project is to gather information from key stakeholders such as judges, attorneys, social services, CASA (advocates/staff), and families. It was decided that looking to bring in an independent facilitator to facilitate conversation with each of these keyholder groups was the preferred approach. As a result, a Request for Proposal (RFP) was created and sent out in July 2023. The RFP timing was further discussed and due to the tight turnaround of requested responses, the RFP was reissued in August.

Discussions with Potential Partner Organizations

Discussion was held regarding reaching out to our collaborative partners that work with the same demographic of children/families (i.e. St. Joseph's Villa, UMFS, VHBG, Children's Home Society, etc.). The decision was to hold off until we better understand the findings from the Focus Groups first before discussing with other nonprofit organizations.

Data

Shannon has read some research papers on Visitation Centers and reported on some findings/highlights. Work continues to gather additional data for forecasting. Laura Robinson is a May 2023 graduate of Unveristy of Richmond School of Law and was accepted into the Bridges to Practice law fellowship with a placement at CASA. She is sorting through ~1,000 closed case data for important data points.

A draft of FY23-24 budget was presented at the March 2023 Board meeting, and the draft and supporting documents were sent to the Board again in anticipation of the May 2023 meeting. There was opportunity for discussion prior to approval. Jeannine was asked to leave the room for discussion on raises and bonuses.

- Employee bonus and merit-based raises were discussed.
 - Board approved 10% raises for all employees (8% COL, 2% merit), to be reflected in the budget and begin July 1, 2023.
 - The Board approved net bonuses for three employees for FY22-23, to be paid before June 30, 2023. (TS: 5%; KB: 5%; JP: 10%)

A Motion to Approve the budget was made by Bryan Jenkins, seconded by Adam Winston. The FY23-24 Operating Budget was approved, as amended.

Additional Discussion:
