# CASA Story - Remembering Judge Boice

# In Memory of the Honorable William Grant "Bill" Boice, Sr. Founder of Henrico CASA

It is with profound respect and admiration that we share the passing of the Honorable William Grant "Bill" Boice, Sr., a man whose visionary spirit and dedication to our community have left an indelible mark on the lives of countless children. Judge Boice's foresight and recognition of the need for additional support for children and families guided the creation of our Henrico Court Appointed Special Advocates (CASA) program nearly three decades ago.

CASA, initially established in 1977 by Seattle judge David Soukup, emerged from a deep concern about the swift decision-making process that affected the lives of abused and neglected children. Judge Soukup saw a crucial gap: decisions were being made without the comprehensive information necessary to safeguard these children's futures.

Judge Boice, much like the founding principles of CASA itself, recognized the critical need for additional support for children and families in our community. He shared Judge Soukup's concern and recognized the inherent value in the CASA model and its potential to bring about positive change in our community. Judge Boice's unwavering commitment to establishing our CASA program here in Henrico County was a testament to his belief in providing a voice for vulnerable children. He understood that by leveraging dedicated advocates, we could bridge the gap between the complex realities these children faced and the decisions that would shape their lives.

Judge Boice's legacy extends far beyond the courtroom. His dedication to fostering a system of support for our community's children speaks volumes about his character and commitment to justice. He lived a life dedicated to his family and to service, both in his professional capacity as an attorney and Henrico County Juvenile & Domestic Relations Judge, and in his numerous roles within Trinity United Methodist Church and various organizations supporting children's welfare.

Judge Boice's impact on our community will forever be cherished and remembered. As we honor the memory of Judge Boice, let us remember the founding principles of CASA and the profound impact it continues to have on the lives of children. Let us carry forward Judge Boice's vision, ensuring that every child in our community receives the advocacy and support they deserve... And may his legacy inspire us all to strive for a more just and compassionate world for our children.

# **AGENDA ITEM 6: Old + New Business**

Presenter: Jeannine Panzera

- Fall 2023 Conference Season
  - o Jeannine shared reflections/trends from various conferences that staff attended.
- National CASA Funding Issue
  - Jeannine shared that state and local directors were made aware that National CASA (NCASA) funding is of concern. National CASA has not received funding from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) which has historically been the source of the vast majority of NCASA's funding (\$13M out of their \$17M budget).
  - This issue has resulted in state and local programs who were awarded NCASA grants have not received the funding that was promised. NCASA has also not been forthcoming or transparent about this issue and State Directors have requested several documents from NCASA and issued a FOIA to OJJDP. It has been discovered that NCASA has been designated as a high-risk grantee.
  - The biggest concern that is being discussed by VA CASA programs is related to the trademark and copyright for the CASA brand, as NCASA owns the rights.
  - Jeannine will share additional information and/or updates as received.

- Victims of Crime Act (VOCA) Funding
  - VOCA is financed by Federal criminal fines, fees, penalties, and special assessments and this funds many programs for victims of crime (CASA, Victim Witness, Child Advocacy Centers, etc.)
  - Virginia currently receives \$40M but the VOCA "cliff" is coming; expecting the first round of cuts in 2026 and final reduction by 2030. The hope is that the statewide CASA funding (\$1.6M) will stay level but there is no guarantee.
  - Henrico CASA currently receives \$122,156 from VOCA-allocated funds, which is a significant amount to our organization and funds two-and-a-half key staff positions. It is important to think strategically about how possible reductions might impact us and how we best prepare for any reductions, including the consideration of adding a fund development position to staff.

# Dianne V. Jewell, PT, DPT, PhD, FAPTA Biosketch



Dianne V. Jewell, PT, DPT, PhD, FAPTA is President and CEO of the Sheltering Arms Corporation and Hospitals.

Dr. Jewell has been a physical therapist for 34 years, having practiced in acute hospital, inpatient rehabilitation, skilled nursing, outpatient and community health settings in Richmond, VA. She also held an appointment for 11 years as Assistant Professor in the Department of Physical Therapy at Virginia Commonwealth University (VCU). Additional adjunct teaching affiliations include the Doctor of Physical Therapy programs at the University of Tennessee Health Science

Center, the University of Vermont, Arcadia University and Mary Baldwin University. Prior to joining Sheltering Arms, she focused her efforts on rehabilitation technology as a consultant and then as Director of Clinical Practice, Outcomes and Education at WebPT (Phoenix, AZ).

Dr. Jewell completed her BA at Williams College (1984), her MSPT at Boston University (1988) and her transitional DPT at VCU (2008). She obtained her PhD in health services research and organization also from VCU (2003). She has published multiple peer-reviewed articles and is author of *Guide to Evidence-Based Physical Therapist Practice*, 5<sup>th</sup> edition (Jones & Bartlett Learning, 2022). She also served as managing editor of the *Physical Therapy Journal of Policy*, *Administration and Leadership*.

Dr. Jewell served for 12 years on the Sheltering Arms Corporation and Hospitals board of directors, chairing the board for two and half of those years. She also previously served on the boards of directors of the PCPI Foundation (Chicago, IL), the American Physical Therapy Association (Alexandria, VA) and the American Association of Cardiovascular and Pulmonary Rehabilitation (Chicago, IL).

She resides in the City of Richmond with her husband of 31 years, Capt. Darl ("Deuce") W. Jewell, Jr. He is a retired 41-year veteran of the Richmond Department of Fire and Emergency Services.
