## **CASA Story**

As stewards of children's welfare at CASA, we are witnessing a concerning trend firsthand: a surge in youth mental health challenges. This is not just a statistical anomaly; it is a pressing reality for the children we serve. As we strive to understand the roots of this crisis, recent research sheds light on a pivotal factor: the profound impact of smartphones and social media on adolescent well-being. This recent article delves into the depths of this issue, offering insights into why we are witnessing such a troubling trend among the youth in our care.

## Screens Are Poisoning Kids' Minds

A shocking number of American kids are sad, suicidal, and stuck on small screens sucking away their zest for life.

Why it matters: This is the indisputable and alarming trend among American children, based on the latest polling and deep research by an NYU professor in a book out next week.



**The big picture**: The pandemic is often cited as a driver of the teen mental health crisis, but it was brewing long before then. A growing body of research links the acceleration of the crisis to one of this century's biggest events: the arrival of the smartphone.

"Smartphones and social media fundamentally changed the way teens spend their time outside of school," says Jean Twenge, a psychologist and author of the book "Generations." "You take a generation of young people, they're spending a lot more time in their rooms, alone, not sleeping, not hanging out with their friends in person. That's a pretty bad formula for mental health."

**By the numbers**: While the teen mental health crisis was slowly developing in the early 2000s, it rapidly worsened in the mid-2010s — which was also when teens' smartphone and social media usage spiked, Jonathan Haidt, the NYU professor, notes in his forthcoming book "The Anxious Generation."

Rates of depression and anxiety among U.S. adolescents were "fairly stable in the 2000s" but "rose by more than 50% in many studies from 2010 to 2019," Haidt writes in The Atlantic. The suicide rate for kids between the ages of 10 and 14 tripled between 2007 and 2021, according to the CDC.

The share of U.S. high school girls who seriously considered attempting suicide jumped from 19% in 2011 to 30% in 2021, per the CDC. The share of boys who considered suicide rose from 13% to 14%. Just 1 in 3 12-to 17-year-olds say things are going well for children and teens today, per a recent Common Sense Media survey.

**Zoom in**: In study after study, teens say social media is making them stressed and depressed, but the time they're spending online keeps rising. In the early 2000s, middle and high school kids saw friends in person about 3 times a week. Now, that's closer to 1.5, according to data from the University of Michigan's Monitoring the Future project.

At the same time, screen time has skyrocketed. Teens spend an average of 4.8 hours on social media apps like TikTok, Instagram and Snapchat every day, according to Gallup. Among teen girls, that ticks up to 5.3 hours.

Teenagers are inundated with notifications, with one study estimating they get 237 pings a day, Haidt notes.

What to watch: TikTok's fate in the U.S. is currently being debated in Congress. If the app disappears from phones — though that's unlikely to happen any time soon — that would force a massive shift in how American teens spend their time. "It's of course possible that people will replace TikTok time with YouTube time or Instagram time," says Twenge. "However, TikTok's algorithm is particularly effective at getting you to spend more time on it."

## AGENDA ITEM 5: Fund Development Report – Rutherfoord Ferguson

## • 2024 Home for Good® Playhouse Event

- The Sponsorship Goal (shooting for the stars) is \$140,000. We have currently raised \$120,000 (12% increase from last year's sponsorship total, and 25% higher than planned revenue of \$95,000 in current operating budget).
- There is also an aggregate CASA Board Sponsorship group that Board members are encouraged to donate to reflect to the community the Board's support for this event.
- Sponsorship deadline for signage (\$1,000 and above) is March 31, 2024.
  Sponsorships are still encouraged after the deadline, and will be promoted on our website, social media, etc.

## • Donations for Opportunity to Win

- Reminder that shortly, attention will turn to promoting Ticket Sales/community outreach for donations for the opportunities to win a playhouse.
- All Board members received a stack of postcards to distribute; CASA Ambassadors are also hard at work at identifying places that will display the postcards.

## AGENDA ITEM 6: Old + New Business – Jeannine Panzera

- DCJS Audit Results
  - DCJS Audit is complete and DCJS compliments CASA Staff and Board on exemplary work. There was no follow-up required from the audit.

## • Visitation Center – Focus Group Project Update

- Knowledge Advisory Group was hired for this project; Focus Group Discussions were completed at the end of February 2024 with Judges, Attorneys, Social Services, and CASA (Staff and Advocates).
- The report is being developed, but draft high-level findings include:
  - The need for a Visitation Center is great.
  - Current supervised visitation scenarios pose clear challenges for families, children, case professionals, and the court process/resolution of cases.
  - There may be suggestions that a center might include additional classes and support for parents.
  - Need for accessibility in a central location, accessible on the bus line, was clear, along with the need for child and family-friend spaces that also takes safety into consideration.
  - A consideration will be about where funding comes from and how will it be sustained.
- The Report will be completed in mid-April 2024. It will be shared with the Visitation Center Committee, and then be shared with the Board at the May 9, 2024, Board Meeting.
- As current Chair, Chris created the current Ad Hoc Visitation Center Committee. In June 2024/end of the fiscal year, he will dissolve the current Committee. This will allow the ability for the next Chair to re-commission a Visitation Center Committee and/or Steering Committee as needed.

## • Staff Update

- Marie Gordon will be retiring at the end of March 2024. Marie will continue to volunteer time as an outside bookkeeper to reconcile accounts and assist with the audit. We are most grateful for her service and ongoing commitment!
- Kerri Green, a current advocate, will be taking over the Financial and Program Administrator position. Kerri has a background in finance and corporate consulting in company processes. Kerri is currently training with Marie and her first official day in the office will be April 9, 2024.
